New Funding for Forest Conservation

A national conservation group has set up an \$18 million fund to conserve forest in New Hampshire, Vermont and Maine, among other states, as a way to fight climate change. The upper valley is one of the target areas of focus for the group. The \$18 million dollar fund will be awarded as grants to local conservation projects.

Cody- moved that we research and apply for a grant. Thomas seconded. Motion passed unanimously.

Cody will investigate the core requirements and will report back to the group.
